- 2. Approval of September 16, 2016 Meeting Minutes (MSP: Gorsiski, Trejo)
- 3. Expansion Updates: Relocations, Plans, Timelines, Etc.
 - A. Sorensen states there is now a fence around the North side of the Union and the make ready work for expansion is underway.
 - **B.** Sorensen shows the Union expansion plans and reviews the changes to these plans since the last meeting.
 - a. The building is now four feet shorter due to the unexpected change in the location of an existing gas line. In addition, there is an exit from the Starbucks but no longer an entrance from the exterior.
